~~RULES ON EDUCATION OF RADIOLOGICAL TECHNOLOGIST~~

- Have seen the Constitution of the Kingdom of Cambodia,
- Have seen the Royal decree No. សន-រក្ខត/07041/124 on July 15, 2004 on the nomination of Royal of Cambodia,
- Have seen Royal decree No. សន-រក្ខត/0303/129 on March 31, 2003 on the accreditation of high education,
- Have seen Royal Kram No. សន/រក្ខត/0196/96 on January 24, 1996 about the law on the establishment of the Ministry of Health,
- Have seen sub-decree No. 67 អនក្រ-បក on October 22, 1997, about the preparation and the practice of the Ministry of Health,

DECIDE

- Article 1:** Apply efficiently the standard rules on the education of radiological technologist in order to respond to the needs of the health serve
- Article 2:** A qualified Radiological Technologist holds a certificate issued by the school that recognized by Ministry of Health and those who are capable of using radiological devices including the Magnetic Resonance diagnostic Imaging (MRI) equipment and others as assistance of medical examination.
- Article 3:** The certificate of radiological technologist issued by the Ministry of Health, is equivalent to the diploma of nursing
- Article 4:** Any institution that is responsible for education of radiological technologist shall have standard rules as following:
- Have a structure of management for administration and technical for the process of the education
 - Have a curriculum approved by the Ministry of Health
 - Have enough teachers as stated in the curriculum:
 - o Theory teaching: teacher and students 1=10
 - o Practice teaching: teacher and students 1=2-5
 - Have the classrooms with appropriate to the number of students (the size is at least 1.30 m² for one student)

- Have the experimental rooms (the size is at least 3.30 m² for one students) equipped technically with practical equipments/devices and with safety insurance
- Have the library with the appropriate size (able to admit 15% of students of all sections) and new publications of books/documents or references for all concerned subjects.
- Have a hospital or a center with enough equipments/devices as stated in the curriculum and well running for students to do practice, and have contract as partners.

Article 5: The criteria of teachers for radiological technologist course are as following:

- Have a professional certificate accordance with the subjects in the curriculum and at least three-year clinical experiences
- Have at least three-years pedagogy experiences or have been trained on teaching methodology
- Knowledge of foreign languages and basic knowledge on computer is preferred
- Good behavior and morality

Article 6: The teachers's recruitment is the authority of the School Director through the recruitment committee based on the criteria stated in the Article 5 prior officially nominated

Article 7: The basic conditions for selecting students to enter the course of radiological technologist

- All the students must holds a diplomas of high school or other equivalences
- The age is at most 23 years counting up to the deadline of application day. This age limitation can be changed according to the selection condition of registration of Ministry of Health
- Have good capacity and good health

Article 8: The students' selection to enter the course is the authority of Ministry of Health that will set the criteria and the procedure for selection by following the Article 7 and as necessary

Article 9: Every institution that provides radiological technologist education needs to fulfill every rules and at least 70% of the rules stated in the Article 4. Then, the institution is permitted to run the course, based on the evaluation of the committee of Ministry of Health.

Article 10: Every institution that provides radiological technologist education has three years to fulfill the above standard rules counting from the opening day of the institution

Article 11: The General technical Director for Health, General Director for administration and finance, general departments, educational institutions, and concerning organizations shall follow this ~~B~~ BRAKAS effectively from the date of signature.
