Minister for Health

In pursuant to:

- The National Constitution of Kingdom of Cambodia.
- Royal Decree No. នស. រកត.០៩០៨.១០៥៥ dated 25th September 2008 on the appointment of the Royal Government of the Kingdom of Cambodia
- Royal Law No. ០២/នស/៩៤ dated 20th July 1994 on promulgation of law on the organization and functioning of the Council of Ministers.
- Royal Law No. នស- រកម-០១៩៦-០៦ dated 24th January 1996 on promulgation of law on the establishment of the Ministry of Health.
- Royal Decree No. ២០អនក្រ-បក dated 30th April 1996 on the promulgation of the law on organization and functioning of the Ministries and Secretariats,
- Sub Decree No. ៦៧ អនក្រ/កត dated 22nd October 1997 of the organization and functioning of the Ministry of Health.
- Royal Decree No. នស/ រកត/០៦១០/៤៦៦ dated 2nd June 2010
- Prakas No. ៧០៤ ស.ខ.ល dated 6th October 2008 of the Ministry of Health
- the remembrance of the meeting of senior management on 21st June 2010.
- Based on the necessary of the Ministry of Health.

Hereby Decides:

Article 1: The key responsibilities have been rearranged for his Excellency Secretary of State as below:

1. His Excellency Eng Huot: Assist his Excellency Minister on the tasks:

- Direct the Health Sector Supporting Program (HSSP) and Special Operation Agency (SOA)
- Infection Control- Quarantine
- Mother and Child's Health (MCH)
- Mental Health
- Continuous Training (Disease Prevention)
- ASEAN affairs

2. His Excellency Te Kuy Seang: Assist his Excellency Minister on the tasks:

- Disaster management
- Administration
- Personnel Management
- Decentralization and deconcentration

Article 2: The responsibilities have been delegated to Excellency Thir Kruy, Secretary of State, to assist his Excellency Minister on the tasks:

- Quality improvement
- Continuous Training (Nursing care and Medicine)
- Inspection.
- Basic education
- Coordinate with Medical council and nursing council.

Article 3: Roles of his Excellency Heng Tay Kry, His Excellency Ing Phirun, His Excellency Sok Pheng, Lok Chumteav Ouk Munna and His Excellency Chou Yinsim as mentioned in Prakas No. 704 ៧៤២.៧ dated 6th October 2008 should be remained.

Article 4: Cabinet, all Directorate General of Administration and Finance, Directorate General for Technical Health and Directorate for Inspection, all health institutions at mid-level and provincial –capital level, as well as His Excellency and Lok Chumteav should abide to as what have been stipulated in Article 1 and Article 2 from the date of signing hereafter.
