## **Amendment to Article 51**

## Of the Law on the Common Statutes of Civil Servants

## The same article -

Article 51 of the Law on Common Statutes of Civil Servants is amended as follows:

## New Article 51 -

In case any civil servant commits a criminal offense and is charged by a prosecutor, the prosecutor shall provide notice about that charge to the director of the institution concerned within 72 hours at the latest;

In case of arrest, detention or temporary detention of any civil servant, the competent prosecutor or judge shall make an immediate report to the director of the institution concerned;

In case the offense is committed within the framework of serving public work, the state shall protect the said civil servant in accordance with the law.
