Royal Government

- Having seen the Constitution of the Kingdom of Cambodia
- Having seen Royal Decree NS/RKT/0704/124 dated July 15, 2004 on the appointment of the Royal Government of the Kingdom of Cambodia
- Having seen Royal Kram 02/NS/94 dated July 20, 1994 promulgated the Law on the Organization and Functioning of the Council of Minister
- the necessity of the Royal Government

Decides

Article 1:

To establish a national training committee in abbreviation "K.C.B.B" to coordinate with relevant ministries, institutions and organizations to develop vocational training system in order to respond to the needs of current socio-economic conditions and the future of Cambodia.

Article 2:

The national training committee composes of the following members:

- This committee might have invited 3 representatives from International and National NGOs to participate in the committee.
- General Department of Vocational and Technical Education of the Ministry of Labor and Vocational Training is a permanent secretariat of this national committee.

Article 3:

This national committee has the following responsibilities:

- Prepare policies and national plan regarding to Vocational and Technical Education

- Facilitate and direct the work of vocational and technical education in response to the needs of current and future national economic development
- Propose for reform and develop a vocational and technical education system to be a system of:
 - High quality and effectiveness
 - Link to the priority of national development
 - Respond to the needs of industrial, business, agriculture and service field etc.
 - Having connection, relation between work places and training institutes

Article 4:

- The national committee shall nominate 9 members of Executive Committee which is composed of the following members:

Deputy Minister & Minister in charge of council of minister
Representative of Ministry of Labor Vocational Training
2 Representatives from ministries of royal government entities
2 Representatives of employer
1 Representative of employee
1 Representative of training institutes

- The Executive Committee might have invited 1 representative from IOs or NGOs to participate in.
- Executive Director is a permanent secretary of this executive committee.

Article 5:

This Executive Committee has the following responsibilities:

- Bears overall management of national training foundation on behalf of the national training committee.
- Prepare program and agenda of the national committee meeting
- Propose on relevant vocational and technical education work to the national committee for verification and making decision.

Article 6:

Shall establish a coordination committee for vocational and technical education at respective provinces called provincial-municipal training committee. This committee shall compose of the following membership: Provincial/Municipal Governor as Chairman, Director of Provincial Department of Labor and Vocational Training as Vice-Chairman, Director of Concerned Provincial Departments, IOs, NGOs, Representative of Employer, Representative of Employee and Representative of training institutes as member and office of vocational and technical education of the provincial department of labor and vocational training as secretariat.

Article 7:

Roles of Provincial/Municipal training committee shall be determined in the statutes of the national training committee.

Article 8:

National training committee has rights in using seal of council of minister.

Article 9:

Any provision which is contradicted to this sub decree shall be abrogated.

Article 6:

Minister in charge of council of minister, minister of the Ministry of Labor and Vocational Training, Ministers, Secretary of State of relevant ministries, departments, all provincial/municipal governor, national training committee and members as stated in article 2 and article 4 shall be responsible in effectively implement this sub-decree from date of the signature.
