- Having seen the Royal decree NS/RKT/1198/72 dated November 30, 2004 on the formation of the Royal Government of the Kingdom of Cambodia
- Having seen Royal Kram NS/RKM 0196/06 dated January 24, 1996 promulgated the Law on Establishment of the Ministry of Health,
- Having seen Sub-decree 67 ANKr.BK dated October 22, 1997 on the Organization and Functioning of the Ministry of Health
- Having seen Sub-decree 129 ANKr.BK dated December 30, 2002 on the Management of Regional Training Center for Health
- Having seen Prakas 311 SNB dated May 28, 2003 on the Organization and Functioning of the Regional Training Center for Health
- Based on the necessity of the Ministry of Health

Hereby Decide

Article 1: To implement one-year primary nursing and midwifery curriculum for Battambang RTC, Kampong Cham RTC, Kampot RTC and Stung Treng RTC.

Article 2: Each regional training center shall be responsible for management and education for students who come from provinces as listed below:

- Siem Reap
- Kampong Chhnang
- Pailin
- Odor Meanchey
- Pursat

2- Kampong Cham RTC

- Kampong Cham

3- Kampot RTC

- Kampot
- Kampong Som
- Takeo
- Kep
- Koh Kong
- Kampong Speu

4- Stung Treng RTC

- Stung Treng
- Mondulkiri
- Kratie
- Ratanakiri
- Preah Vihear

Article 3: Students who successfully pass the exit examination of primary nursing and midwifery course will receive a diploma of primary nurse or primary midwife issued by Ministry of Health.

Article 4: Human Resource Development Department has duties to govern, monitor, and evaluate the implementation of primary nursing and midwifery curriculum at each RTC with collaboration of relevant RTC.

Article 5: Directorate General for Health, Directorate General for Admin and Finance and Battambang, Kampong Cham, Kampot and Stung Treng RTC have the duties to implement according to the Prakas from the date of signing hereafter.

Article 6: Content of any Prakas which contradicted to this Prakas shall deem abrogated.
