of the Ministry of Health**



THE ROYAL GOVERNMENT

- Having seen the Constitution of the Kingdom of Cambodia;
- Having seen the Royal decree NS/RKT/0908/1055 dated 25 September, 2008 on the appointment of the Royal Government of the Kingdom of Cambodia;
- Having seen the Royal Kram No. 02/NS/94 dated 20 July, 1994, promulgated Law on Organization and Functioning of the Council of Ministers;
- Having seen the Royal Kram NS/RKM/0196/06 dated 24 January, 1996 promulgated the Law on Establishment of the Ministry of Health;
- Having seen Sub-decree No. 20 ANK.BK dated 30 April, 1996 on the organization and functioning of the Ministries and State-Secretariats;
- Having seen Sub-decree 67 ANK.BK dated 22 October, 1997 on the organizing and functioning of the Ministry of Health;
- Having seen the request of Minister of Health;

HEREBY DECIDES:

Chapter I

General Provisions

Article 1: A Legislative Department shall be established under the General Directorate Department of Administration and Finance in accordance with the Sub-decree No. 67 ANK/BK, dated 22 October, 1997 on the Organizing and functioning of the Ministry of Health.

Article 2:

The Department of Legislation has its roles and duties as the following:

- The arms of the Ministry of Health responsible for legislative development;
- To develop and draft the law, regulations, and policies related to health in collaboration with relevant institutions;

- To review, suggest, and revise draft law, legal text and regulations of the Ministry of Health
- To provide training and dissemination of the existing laws, regulations, and policy that are relating to health;
- To monitor and evaluate the implementation of the laws that are related to health;
- To cooperate with relevant units to oversight the implementation of the law that are related to health;
- Shall collaborate with relevant units while preparing all relevant documents of both either legal or juridical processes to deal with the conflict that is relating to health;
- Manage the Ministry's library and distribute royal gazette;
- Compile and archive legal documents and laws that are related to health;
- Make periodic report of the department's activities and submit it to the leaders of Ministry of Health;
- Other tasks as assigned by Ministry of Health's leaders;

Article 3:

The Department of Legislation shall be led by one director of department with few deputy directors of department according to the need;

The departmental structure, organizing and functioning of the subordinated offices the legislative department shall be determined by the Prakas (proclamation) of the Minister of Health.

Article 4:

Any provision that contrary to this Sub-decree shall be nulled and void.

Article 5:

The minister in charge of council of Ministers, minister of Economy and Finance, minister of Health, ministers, secretaries of state of all ministries, relevant institutions shall have to implement this Sub-decree from this date of signature.
